## Alpha's Reunion Sets Fire to Tarkio College Alumni Weekend Festivities

The Delta Gamma Chapter of Alpha Sigma Phi Fraternity, the first national fraternity to receive its Charter at Tarkio College, again displayed its leadership by participating in the Alumni Association Weekend at Tarkio, Missouri.

In June, the brothers met in Tarkio for the third time in just four years, honoring the bonds made in the fall of 1970 when the fraternity was awarded its charter. Several participants this year were among those original members as well as others who began as members of Alpha Lambda Sigma, a local fraternity - the roots of Alpha Sigma Phi here in Tarkio.

It is because of Alpha Sigma Phi and the pursuit of the brothers of Alpha Lambda Sigma that opened the door for other national fraternities to call Tarkio home.

Well known Chicago Blues Musician and Alpha brother Norm “Mad Dawg” Siegel made the trip from Chicago to be a part of this year’s festivities. “This is my first time back to Tarkio since the early seventies,” he said. “It’s hard to express in words how overwhelming it is to see these guys and be back in Tarkio again. This has been truly eye-opening and amazing in all the great ways. I’ll be back.”

“Norm’s synopsis seems to be typical of how all of us view being here,” says Wayne Gelston. “We all have such a wonderful bond with each other. We did a lot of stuff together but what really sticks is this place – Tarkio itself. That’s what it is really all about.” Gelston, who made the trip from Pennsylvania, is also an original Lambda remembered for his many stage appearances at the Mule Barn Theater.

The Alphas have agreed to reunions in Tarkio on a bi-annual basis with the next full event being planned for The Alumni Weekend in June of 2011. According to one spokesman, “it will not be anything short of great!”

The brothers have routinely taken the lead for other fraternity to follow by participating in the Alumni Weekends. In their first group visit to Tarkio in 2005 they took up a collection for the museum and donated several items too. This year the brothers organized a Main Street Parade which culminated at The Museum- bringing further attention to this cause. They extend an open invitation to other fraternities and sororities to come together here in Tarkio in conjunction with The Annual Alumni Weekend.

## **PROGRESS ON SENIOR HOUSING PROJECT**

New Hope Health Care, Inc., a Scranton, Pennsylvania based national health care consulting firm has completed the first phase of the three phase study on the potential for a multi-service project for seniors on the campus of the former Tarkio College. The Need Analysis was submitted to the board of directors of Heartland Educational Institute for review. The study concluded that there is a significant need in the primary target area, which includes four counties in Missouri and three each in Iowa and Nebraska, for some senior services. While the study concludes that some need does exist, the second phase of the study, which is currently underway, will reveal the concept design, as well as the feasibility of such a design to meet those needs. When complete, the final phase of the study will be to conduct a market study to properly determine if the market will support the concept.

It is important to segment the various phases of the study. Too often this process is done all at once to save time and money, but proves, at a later date, to be inaccurate. It is far better to segment the process and follow the logical process to first determine needs, then design a program to meet the needs, determine the feasibility and finally ascertain the potential for the project to be successful in the market place. This allows for modifications to assure the sponsor and potential clients, as well as the local community, that the project has a high probability of success. Many of the most successful senior projects in the nation have followed this time tested planning model.

The final decision on the project will be handled by Heartland Educational Institute.

## **SPECIAL OPPORTUNITY**

Congress approved a measure that donations made from tax-sheltered retirement accounts to non-profit organizations, such as Tarkio College Alumni Association, during FY 2009 will not be taxed.

Although mandated withdrawals from retirement accounts for those of us over the age of 70-1/2 have been given a one-year hiatus for 2009, transferring of charitable gifts this year still offers one the opportunity to give funds tax-free.—an opportunity that may not be available in future years. The potential for future tax increases on mandated withdrawals is yet another reason to donate to TCAA this year.

Rebecca A. Matthews '77, Grand Island, NE, passed away October 19, 2009. She was a talented pianist who shared her gifts with others.


