A Letter From The Presidentof Tarkio College

Dear Alums.

There are times I feel like the preverbal prophet who stands on the street corner with a sign saying, "The End is Near". For twenty-five years many of us have toiled to bring about the rebirth of Tarkio College and each year we pronounce that the end of our journey is "near". The problem is in the definition of "near". In the space of the universe "near" could be a hundred or a thousand years, but in our universe "near" must be defined by the limitations brought about by the fragility of mankind. So when you hear those of us who have been on this journey say that we are "near" the end please understand two things, "near" is based on the limits those of us who have dedicated our lives to this process have and that the concept of "end" is really just the beginning of the next saga for Tarkio College.

As you may be aware, Heartland Educational Institute has granted the campus to the Alumni Association. This makes a major difference in our approach to the Missouri Department of Higher Education. As Dr. John Fisher and I develop the plan for approval by the Department of Higher Education the arrangement of classes and the utilization of buildings can be more campus focused. Part of the application process is a calculation of our assets and a reasonable budget to operate a post-secondary school. The campus now becomes an unencumbered asset boosting our balance sheet and makes the budget look similar to other postsecondary schools, which in the world of regulators is a good thing. Our goal is to complete this complex application so that the actual process of review by

the State of Missouri can take place early in 2016. Initially the board plans to use Rankin Hall and the learning center (Thompson) as the core classroom space. Alumni President Wayne Gelston and Board Member Don Jagger have been working diligently to get the learning center ready. It will take a great deal more work, but the initial processes of turning on the power, checking systems, getting water to the building and soliciting bids to do some of the work are already underway. In addition, the Board Directors selected Jeffrey Bryne and Associates as fund raising counsel and they will complete the necessary study and operate the major fund raising campaign.

Tarkio College will begin providing classes using a traditional associate degree program. The curriculum is being developed using criteria used among many Missouri colleges to enhance transferability of credits. Classes will be held on campus and on-line. Dr. Fisher and I are following the events surrounding the implementation of Missouri statute 173.020 wherein "the Coordinating Board for Higher Education (hereafter referred to as the coordinating board) shall have the responsibility, within the provisions of the Constitution of the state of Missouri, to: (1) Conduct studies of population and enrollment trends affecting institutions of higher education in the state; (2) Identify higher education needs in the state in terms of the requirements and potential of the young people and in terms of labor force requirements for the development of commerce and industry, and of professional and

public services; (3) Develop arrangements for more effective and more economical specialization among institutions in types of education programs offered and students served, and for more effective coordination and mutual support among institutions in the utilization of facilities, faculty and other resources; (4) Design a coordinated plan for higher education in the state (hereafter referred to as the coordinated plan) and for sub regions in the state, which shall be based on the studies indicated above and on such others as may be deemed relevant by the coordinating board." The goal of Tarkio College is to become an integral part of the postsecondary school system and, in doing so, advance the goals of the Coordinating Board of Higher Education, Once established, Tarkio College can begin to expand the array of offerings and include some of the longer term goals of providing training and education in health care, homeland security, agriculture and technical skills. In addition, Tarkio College wants to become part of "The Missouri Reverse Transfer Program"

which offers seamless associate degree completion by allowing students to use credit earned at twoand four-year higher education institutions to qualify for an associate degree. Students who have completed at least 15 credit hours at a qualifying two-year college and transferred to a four-year college or university in Missouri can transfer credit back to the two-year college to earn an associate degree. Even students who are not currently attending college may be eligible to complete an associate degree through the Missouri Reverse Transfer program.

So, once again I am standing on the street corner with a sign the says, "The End is Near", only this time the reverse side of the sign says "We Have Only Just Begun". Many thanks to those who have stuck with us in this process. It is far better to do things right than to do them fast.

Wills & Trusts

Giving to Tarkio College through your will or living trust is often referred to as a "bequest." A bequest from your estate may include cash, securities, real estate, and/or personal property. It can be for a specific amount or for a percentage of your estate.

Why Include the Tarkio College in Your Will?

How Do You Make a Bequest to Tarkio College?

If you are writing your will or living trust, you will need to include specific language that correctly identifies your support of Tarkio College. If you already have a will, you can add a codicil or amendment to your existing estate plan. Or, if you already have a living trust, you would simply modify the language, directing your trustee to make the desired distributions.

Sample Bequest Language:

Unrestricted Bequest – for College-determined purposes

Restricted Bequest – for a purpose you define

Informing Tarkio College of your gift does not obligate you or your estate in any way; it simply helps the College fully understand your gift intentions and ensures that there is a plan in place for implementing them. For example, if you would like to endow a scholarship, the Office of the President can assist you in establishing the terms of that scholarship. Additionally, it allows the College to thank you appropriately. Of course, it is understood that you may change your bequest at any time.

Endowment Gifts

Endowment gifts from alumni and friends provide a permanent investment in Tarkio College's future. An endowment sustains academic excellence by ensuring a continuous source of funding for hands-on learning, new classrooms, merit scholarships, and faculty research. From major gifts that recruit prestigious scholars to targeted gifts that support an annual student prize in a specialized field, each endowment fund enriches the campus.

When endowment gifts are received, the principal is held in perpetuity, with part of the annual earnings generating ongoing support for activities designated by the donor. Although tuition levels and fundraising revenue might fluctuate annually, the stability of an endowment encourages strategic planning and program expansion.

Tarkio College's combined endowment pool should experience growth due to careful management of assets and the increasing generosity of donors. Prudent investment policies balance stocks and bonds for asset diversity to maintain purchasing power over time and overcome inflation in higher education costs.

Named funds not only make a lasting impact at Tarkio College, but also

offer the opportunity to honor your

family's commitment to Tarkio College or pay tribute to a loved one. Endowments can be established through contributions of cash, stock, real estate, charitable remainder trusts, or bequests. Pledged payments on an endowment normally over a period of years, are welcome.
