

Tarkio College, its students, alumni, staff and faculty, was her life focus for thirty-two years (1932-1979) Crystal served as administrative secretary to three presidents:


Dr. M. Earle Collins, Dr. Clyde Canfield, Dr. William Schechter

Staff Sgt Norman Nell '45, Tarkio, was laid to rest at Arlington National Cemetery on September 6, 2007.

Norman was killed when his B-24 Liberator went down in the Morobe Province of New Guinea on April 16, 1944. The crash site was discovered in 2001 and excavated in 2002. Norman's remains were identified through DNA of family members and by his high school class ring that was found at the site.

Norman's mother lived to be 102, but apparently died without knowing his body had been found.

Norman's class ring and other memorabilia are now on display in the Atchison County Historical Museum in Tarkio.

A moment of silence was held for Norman at our 2007 Alumni Weekend banquet.
